# Re: Zoning Ordinance Text Amendment and Sketch Plan Submission

Dear Mr. Marabella:

On behalf of Provco Pineville Fayette, L.P., the equitable owner of the property located at 1109-1201 Fayette Street, enclosed are the following 2 applications:

# 1. Zoning Ordinance Amendment.

Pursuant to Part 5, §27-501 and § 27-502 of the Conshohocken Borough Zoning Ordinance of 2001, a proposed amendment of Chapter 27 of the Conshohocken Borough Zoning Ordinance specifically, §27-1202.

This amendment proposes to change the text of the zoning ordinance, but not the map. Thus, the proposed amendment is <u>not</u> a request for rezoning. As you are well aware, the zoning ordinance amendment is but the first step in the land use process.

After the borough council enacts the zoning ordinance amendment, a full land development application will be required. Land development will include such issues as vehicular and pedestrian concerns, lighting, noise, deliveries, and storm water management. The existing site pre-dates the now applicable stringent storm water management regulations.

# 2. Sketch Plan Submittal.

Pursuant to Part 3, §22 and §23 of the Borough of Conshohocken Subdivision and Land Development Ordinance, a sketch plan depicting the development of the property located at 1109-1201 Fayette Street as a convenience retail food store including the sale of fuel.

- Q. Pursuant to Sec. 27-502.C of the Borough Zoning Ordinance the circumstances and factors in support of the zoning text amendment are briefly summarized below:
  - The subject site is occupied by a new and used car dealership, with service and vehicle/parts storage. This use is non-conforming within the R-0 Residential Office District.

- Permitted and conditional uses (see sec. 27-1202 and 27-1203) are limited in their nature and do not provide a reasonable opportunity to use or redevelop the site for one of these purposes.
- The Declaration of Legislative Intent (see sec. 27-201) does not apply to the subject site because the site does not contain existing Victorian or early 20<sup>th</sup> Century residences, nor is the site now or previously used for residential purposes. Thus, there is no residential streetscape worthy of preservation in this section of upper Fayette Street.
- The subject site is situated opposite a commercial use (the Town Valet Cleaners) and because of its adjacency to both a cemetery and a sports stadium, it is not surrounded by residential uses.
- The amendment will provide for the opportunity to create a use that will both beautify the streetscape and eliminate a distressed non-conforming use. In addition, the use conforms with a recommendation of the Revitalization Plan Update, May 2011, which suggests that the Borough accommodate additional retailers and at Table 16 specifically suggests a convenience store (size of 6,000 s.f. – Wawa will be about 4,100 s.f.).

# AN ORDINANCE AMENDING CHAPTER 27 OF THE CONSHOHOCKEN BOROUGH ZONING ORDINANCE OF 2001, PART 12, R-O – RESIDENTIAL OFFICE DISTRICT, §27-1202, PERMITTED USES, TO ADD A NEW SUBSECTION 5 TO PROVIDE FOR NEW USES, STANDARDS AND SPECIAL REGULATIONS ASSOCIATED THEREWITH

NOW, THEREFORE, it is hereby ENACTED and ORDAINED by the Borough Council of Conshohocken Borough, Montgomery County, Pennsylvania, that Part 12, R-O – Residential Office District, §27-1202, Permitted Uses, shall be amended as follows:

<u>SECTION 1</u>. Part 12, R-O – Residential Office District, §27-1202, Permitted Uses, shall be amended by adding a new subsection 5 to read as follows:

5. The following uses, permitted on properties last occupied or used as a nonconforming commercial use, provided that the property does not contain a Victorian or early 20<sup>th</sup> Century residential structure.

### A. Permitted uses:

- (1) Business offices including, but not limited to, security and commodity brokerage, real estate sales, travel agency, employment counseling, insurance sales, advertising, mailing and stenographic services.
- (2) Professional office for the practice of medicine, law, engineering, architecture or design, real estate, insurance, or financial institution.
- (3) Retail establishment for the sale of dry goods, variety merchandise, clothing, food, baked goods, beverages, flowers, plants, drugs, hardware, books, and furnishings.
- (4) Restaurants excluding drive-in or drive-thru.
- (5) Convenience retail food store including the sale of fuel. No convenience retail food store which provides for the sale of fuel shall be located within 1,000 feet of another convenience retail food store which provides for the sale of fuel.
- (6) Parking lots or garages, provided that they are secondary to the principal use.
- B. Permitted uses shall comply with the dimensional standards of §27-1205, except as set forth below:
  - (I) The minimum lot width shall be two hundred and fifty (250) feet on a state highway.
  - (2) The minimum lot size shall be forty thousand (40,000) square feet.
  - (3) The minimum side yard shall be twenty-five (25) feet.
  - (4) The maximum impervious coverage shall be ninety percent (90%) of the lot area.

(5) Fuel pumps shall be set back at least fifteen (15) feet from any ultimate right-of-way

### C. Special regulations.

- (1) Prohibited are any adult use and activity defined in §27-202 herein.
- (2) A lot may have more than one accessway on each street, subject to the following regulations:
  - (a) Accessways shall be separated by a distance of not less than one hundred (100) feet.
  - (b) Where a driveway is limited to right-in/right-out, the width of each lane of a right-in/right-out driveway shall not exceed sixteen (16) feet, provided that, in the case of a driveway on a state road, the lane width may exceed sixteen (16) feet if required by PennDOT. The provisions of this subsection shall supersede §27-2007.1.

## D. Sign regulations.


- (1) One (1) monument sign, which may be internally or externally illuminated, consisting of not more than fifty (50) square feet and positioned not greater than ten (10) feet above ground elevation.
- One (1) building wall sign, which may be internally or externally illuminated, of not more than seventy (70) square feet.
- (3) If fuel pumps are provided, then one (1) sign per pump not greater than two (2) square feet each shall be permitted.
- (4) Directional signage, which may be internally illuminated, shall be permitted at each entrance drive, not to exceed two (2) directional signs per driveway access and each not greater than two (2) square feet in area.

<u>SECTION 2.</u> Severability. In the event that any section, sentence, clause, phrase or word of this ordinance shall be declared illegal, invalid or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent, preclude or otherwise foreclose enforcement of any of the remaining portions of this ordinance.

SECTION 3. Repealer. All provisions of the Conshohocken Borough Zoning Ordinance unaffected by this Ordinance are declared to be in full force and effect. All provisions of the Conshohocken Borough Zoning Ordinance inconsistent with the provisions of this Ordinance are hereby repealed to the extent of the inconsistency.

**SECTION 4. Effective Date.** The provisions of this Ordinance shall be effective in five (5) business days after its adoption.

  - e.) County review fees (if applicable).
- 3. Within ten (10) days of receipt of an application the Borough Planner will complete a "review for completeness". Applications deemed incomplete will be returned to the applicant with plan or submission deficiencies indicating in writing.
- 4. Applications deemed complete will be distributed to the following individuals:
  - a.) Planning Commission members (5)
  - b.) Community Development and Zoning Officer (1)
  - c.) Borough Solicitor (1)
  - d.) Borough Planner (1)
  - e.) Borough Engineer (1)
  - f.) Borough Code Official (1)
  - g.) Fire Marshall (1)
  - h.) Police Department (1)
  - i.) County Planning Commission (1)
  - i.) Borough Files (1)
- 5. Pursuant to Section 508 of the Pennsylvania Municipalities Planning Code all applications "deemed complete" for preliminary or final land development or subdivision will be acted upon by the governing body no later than 90 days following the date of the regular meeting of the Planning Commission next following the date the application was deemed complete or, if the next regular meeting should occur more than 30 days following the filing of the application, the said 90-day period shall be measured from the 30th day following the day a complete application has been filed.

On behalf of Provco Pineville Fayette, L.P., the equitable owner of the property located at 1109-1201 Fayette Street, enclosed are the following 2 applications:

### 1. Zoning Ordinance Amendment.

Pursuant to Part 5, §27-501 and § 27-502 of the Conshohocken Borough Zoning Ordinance of 2001, a proposed amendment of Chapter 27 of the Conshohocken Borough Zoning Ordinance specifically, §27-1202.

This amendment proposes to change the text of the zoning ordinance, but not the map. Thus, the proposed amendment is <u>not</u> a request for rezoning. As you are well aware, the zoning ordinance amendment is but the first step in the land use process.

After the borough council enacts the zoning ordinance amendment, a full land development application will be required.   - The subject site is occupied by a new and used car dealership, with service and vehicle/parts storage. This use is non-conforming within the R-0 Residential Office District.

- Permitted and conditional uses (see sec. 27-1202 and 27-1203) are limited in their nature and do not provide a reasonable opportunity to use or redevelop the site for one of these purposes.
- The Declaration of Legislative Intent (see sec. 27-201) does not apply to the subject site because the site does not contain existing Victorian or early 20<sup>th</sup> Century residences, nor is the site now or previously used for residential purposes. Thus, there is no residential streetscape worthy of preservation in this section of upper Fayette Street.
- The subject site is situated opposite a commercial use (the Town Valet Cleaners) and because of its adjacency to both a cemetery and a sports stadium, it is not surrounded by residential uses.
- The amendment will provide for the opportunity to create a use that will both beautify the streetscape and eliminate a distressed non-conforming use. In addition, the use conforms with a recommendation of the Revitalization Plan Update, May 2011, which suggests that the Borough accommodate additional retailers and at Table 16 specifically suggests a convenience store (size of 6,000 s.f. – Wawa will be about 4,100 s.f.).
