Dear MCRC Committee People,

I am writing to let you know that I am stepping down as Chair of MCRC and the March 1st County Endorsement Convention will also be a meeting to elect a new Chair. It has been an honor to lead this committee for nearly 5 years, but it is time for me to focus more on my legal practice which now includes being the General Counsel to the National Constitution Center in addition to my corporate finance practice at Dilworth Paxson. I will remain the PA Republican Party Secretary and am thrilled to continue helping manage our state party-endorsed candidate Montgomery County's Own President Judge Carolyn Carluccio's race for PA Supreme Court.

I am very proud of what we have accomplished together over the last 5 years. With the help of a great team led by our outstanding Executive Director, Julia Vahey, we transformed the way MCRC operated. We refocused our efforts down to the township level, creating a separate fund where we raised and contributed over \$300k to local candidates. We provided trainings for our local candidates, produced election materials, and organized campaign events at the local level across our county made up of 62 municipalities. Although we may not have won as many races as we would have liked because of the changing demographics we did help local townships win that are democrat in registration, and we taught our candidates and our committees how to FIGHT!

We raised nearly 1.4 million dollars bringing in over 100 new donors. For the first time in over 10 years, we had candidates for every legislative seat in 2022 which we trained and offered resources. We organized regular Days of Action and trainings for committeepersons, candidates, on petitions, on financial reporting, drop box watching, poll watching, etc). We held regular meetings with our Executive Committee creating a solid unified working group for the first time in a decade. We also had great events every other month with exciting national speakers like Kimberly Guilfoyle, Governor Kristi Noem, Corey Lewandowski, Steve Bannon, Scott Rasmussen, Steve Moore, and Scotty Neil as well as prominent Republican leaders from across the State! We saw an increase in Republican voter turnout through our volunteer and paid efforts. This spring we invested in a mailin-ballot initiative in western Montco and recently formed a Mail-in-ballot committee that is readying a plan to produce for our local municipalities countywide. Finally, we led in the fight for election integrity and achieved substantial improvements to our election procedures in Montgomery County. We testified in court and in front of the PA Senate and documented irregularities in detail and made reasonable recommendations for improvements. I appeared before our county commissioners, and because of our persistence, we obtained the best drop box security from a county voter services in the state.

I am tremendously proud of the work we have done together, and the great friendships I have made these last few years. I thank you for your dedication to the Montgomery County Republican Committee, and I look forward to seeing you on March 1st.

The MCRC Meeting will take place on March 1st at the Crowne Plaza Hotel 260 Mall Blvd, King of Prussia, PA 19406. There will be plenty of parking.

At this meeting, we will elect a new MCRC Chair and endorse candidates for countywide positions. If you cannot attend this meeting, please complete the enclosed proxy form below and give it to another registered Republican from your Area. Committee people can carry 1 proxy, and a non-committee person can carry 2 proxies. This is a private meeting - Only committee people and approved proxy holders will be allowed to enter this meeting. Please bring Photo ID as it will be required to enter this meeting. MCRC has hired security guards who will admit you at the entrance. MCRC will not tolerate any disorderly conduct. Anyone who attempts to disrupt the meeting or acts disorderly will be removed from the meeting.

Unlike previous MCRC Meetings, there will be a staggered check-in schedule to prevent long lines and to ensure the process runs smoothly. Check-in will begin at 5:40pm and the meeting will approximately begin at 7pm. Please see the check-in schedule for each Area below. If you plan to run for any of the positions being voted on at this meeting, you need to contact MCRC in writing to ensure the process runs smoothly.
